## William C. And Carol Kilcoyne Grant Program

The William C. and Carol S. Kilcoyne Continuing Education Grant was established in 2004 to recognize the significant contribution the Kilcoyne's have made to the development and continuity of MRPA. Mr. Kilcoyne was a past president and long-standing treasurer of MRPA with over 27 years of service as the park & Recreation Director for the town of Wayland, Massachusetts. Mrs. Kilcoyne was the Association's first Executive Secretary, serving in that capacity for twenty-one years. To honor the Kilcoyne's commitment to the profession, the MRPA established this annual program to assist professionals pursuing ongoing professional development in the park and recreation industry.

The Kilcoyne Grant Program administers and awards **up to \$500** to fund the registration fees and related material costs associated with Continuing Education Units (CEU's), educational workshops, NRPA Schools and certification programs.

#### Examples of grant awards include:

- MRPA Annual Conference Registration
- NRPA National Conference Registration
- CEU Certified Programming
- CPRP/CPSI Preparation Courses
- NRPA Sponsored Schools (ie. Director School, Event Management School etc.)

#### Grant Awards will NOT cover:

- Conference/Education travel fees (airfare, gas, etc),
- Meal fees or housing accommodations
- Exam Fees for Certification Programs

\*The MRPA Executive board reserves the right to determine if an application meets or does not meet the requirements.

#### **Application Materials**

Application must be accompanied by the following:

- 1. Resume including work, educational and volunteer experiences
- 2. Two letters of recommendation from individuals familiar with your job/educational performance. These letters should include the length and nature of your association, relationship to you, address, phone number and a detailed reason why you are deserving of the grant.
- 3. A completed grant application which is attached

### **Application Instructions & Guidelines**

- 1. Must submit an attached COMPLETED application. Any incomplete application will not be considered.
- 2. Applicant **must be a member** in good standing of the Massachusetts Recreation and Park Association.
- 3. Applicant must be able to show proof that they are presently employed full-time in a paid capacity in the Parks, Recreation and/or Leisure Services field for greater than 12 months OR currently enrolled in an undergraduate or graduate program in the recreation parks area and/or related field.
- 4. Applicant must justify intent of using this award towards furthering their training and/or education.

- 5. All applications must be received by MRPA on a rolling basis. National Recreation and Parks Association National Conference grant applications are due no later than June 30th of the current year. MRPA will not return any materials submitted with the application.
- 6. Please include a detailed brochure/description of desired program including specific fees.
